

## **SPECIMEN RULES**

## FOR AMATEUR ARTISTIC ROLLER SKATING CLUBS

1. ¯	That the Club be called the	Roller Skating	Club.

- 2. That the object of the Club be the promotion and cultivation of roller skating.
- 3. That the Club shall be affiliated to GB Skate Artistic, whose laws shall be preserved in every detail.
- 4. That the Club be non-profit making.
- 5. The membership of the Club shall comprise "Full" (or Senior) Members, who shall be ...... years of age and over. Junior Members who shall be under ...... years of age.
- 7. Membership shall be by application to the Committee, for consideration, who may exercise the right of refusal.
- 8. That no member shall be allowed to compete in any club activities unless he/she has paid his/her subscription.
- 9. That a member wishing to resign must do so in writing before the Annual General Meeting or he/she will be held liable for the ensuing year's subscription.
- 10. Any member acting in a manner derogatory to the Club shall have his/her conduct dealt with by the Committee, which shall afford the member the opportunity of being heard. The Committee shall have the power to expel the member by a majority of two-thirds of those present and voting. Any such members shall, however, have the right to appeal to a special General Meeting of the Club called for the purpose.
- 11. The Committee of the Club shall consist of: Chairman, Treasurer, Secretary, Safeguarding Lead and Committee Members. **Note:** Clubs may, if they wish, elect a President, vice-president, Captain and Junior Representative, who may be ex-officio members of the Committee).
- 12. The guorum for Committee Meetings shall be ...... Committee Members and ...... Official(s).
- 13. In the event of a Committee vacancy, the Committee shall have the power to fill that vacancy with a fully paid-up Senior Club Member. Such Members will have the same powers as though formally elected on at the AGM.
- 14. The Committee shall have the power to co-opt up to one third of their number. Such co-opted members may take full part in all discussions but may not vote.







- 15. The Club will uphold the GBSA Safeguarding policies as set down and as may be amended from time to time by GBSA. A Form confirming the agreement to this statement to be sent to GBSA for the records.
- 16. All members who have not attained the age of 18 must be registered as a child or young person and a Parental Consent Form held by the club.
- 17. All trainers/coaches/teachers or consultants (skating or sports active persons) employed either paid or unpaid must hold a GBSA CPU approval coaches license. [safeguarding license with photo].
- 18. Club Officials involved in the supervision of children and young people belonging to or associated with the Club must also be registered. [Green license with photo].
- 19. That the Committee be empowered to organise skating competitions.
- 20. That discretionary power be given to the Committee to deal with any matter not provided for in these rules.
- 21. That proper account books be kept by the Honorary Treasurer, who shall arrange for these to be audited annually, by a person appointed by the AGM.
- 22. That an Annual General Meeting must be held each year, at which the Officials and Committee Members for the ensuing year shall be elected.
- 23. That ...... clear days' notice shall be given to all members of any General Meeting.
- 25. At any General Meeting of the Club, the Junior Members may attend and speak, but only the Full (or Senior) Members shall be entitled to vote on any question raised.
- 26. A resolution to dissolve the club can only be passed at an AGM or EGM through a majority vote of the membership. In the event of dissolution, any assets of the club that remain will become the property of NAME OF GOVERNING BODY OR SOME OTHER CLUB WITH SIMILAR OBJECTIVES TO THOSE OF THE CLUB.
- 27. No competitive restrictions shall be imposed on any member who wishes to leave the Club.
- 28. That none of the foregoing Rules be altered except at the Annual General Meeting or at a Special General Meeting convened for that purpose, of which seven clear days notice must be given.

Please note, to qualify for affiliation, Rule Nos. 3, 10, 11, 15, 16, 17, 18, 21, 22, 24, 26, 27 and 28 are mandatory.

A list of names and addresses of Officials and Committee Members, together with a copy of the Club Rules, must be forwarded each year after the Club's AGM.
